**INTERNATIONAL DEGREE APPLICANTS**

- A fully-refundable deposit of £250 is required from all international applicants for before we can process your application.
- Please make cheques/bankers drafts payable to Isle of Man Government.
- If you are accepted onto our programme your paid deposit will be deducted from your course fees. If you are not accepted onto our programme your paid deposit will be returned to you in full.
- 50% of the annual tuition fee must be paid at registration at the start of your course, with the remainder paid in January and May, payable within 30 days of the invoice date.

The tuition fees detailed in this document were correct in January 2008.

They are subject to change by the time you come to enrol on and pay for your degree programme.

The fees payable will be the current rate at the time of commencing your degree and not those published in this document.
